The existing permitted use of the Unit 1 Fall Bank Industrial estate premises is for warehouse/distribution centre for commercial stationers. Condition 2 of the permission specifically excludes any retail sales. As such, planning permission is required for a change of use to Trade Warehouse with retail element.

Trading for Unit 1. Total floor space is 9,500 sq ft.

Mezzanine will be 3,000sq foot - This will be trade (No customers on the upper floor)

Floor space on ground level is 6,500 sq foot. Unit 1 has three entrances.

1 entrance will be a shop entrance. The other two entrances occupying this space will be trade and office space.

Therefore, shop floor space will be less than 1/3 of 6,500. Total shop floor space 1952 sq foot estimate = 20.5%

Therefore, trade is 2,166 x2 (plus office space (216 sq ft) and 3,000 sq foot from Mezzanine. Estimate = 79.5%
