We wish to add a Velux heritage roof window to our Grade II listed property. The existing roof already has numerous roof windows installed as part of a major redevelopment that was undertaken in 2004. The additional roof window will add symmetry to the building and it is somewhat surprising that this was not done as part of the original redevelopment in 2004.

We are planning to refresh the existing on-suite bathroom on our top floor, and we want to add a roof window into the bathroom space. The current on-suite bathroom has no window and thus suffers from poor ventilation and lighting. The works to refresh the on-suite bathroom will not change any interior layout, but the addition of a roof window within the bathroom space will greatly enhance the property.

"The proposal to install a new conservation rooflight in a style matching the existing ones I feel does not compromise the building's architectural significance. However, given the building's symmetrical design, I suggest that the new rooflight aligns with the others, specifically in line with the third bay from the left first-floor window. This alignment will maintain the building's symmetry and historic appearance. Though it should be noted that the existing rooflights are a modern alteration which look to be part of the conversion of the building in the early 2000s.

On submission of listed building consent, we would require an elevation showing the existing and proposed works, as well as a clear justification for the change"
