2) erection of a new short corridor link from the existing building to the new modular.
3) refurbishment of 5no. small offices within the building in order to provide a new preparation area for the MRI with patient changing room facilities.

The exterior walls composed of metal sandwich panels with high density structural stone wool insulation. The basic roof construction is assembled of insulated panels. The panels are fixed to the top-rail of the upper structure. A bitumen roofing is applied to the insulated panels. For exhausting helium vapour, an exhaust outlet is installed on the roof. Insulated grey external quality door to the modular.
