T1 - ELM - THIS IS A SIGNIFICANT TREE, WHICH IS APPROXIMATELY 80% DEAD. MULTIPLE AREAS OF PEELING BARK AND RETAINED DEAD WOOD IN THE CROWN. IT IS ADJACENT TO COMMERCIAL AND DOMESTIC DWELLINGS. THIS TREE NEEDS TO BE REMOVED BEFORE ANY LIMBS FALL ONTO ADJACENT PROPERTIES OR THE ROOT-PLATE SHOULD FAIL AND CAUSE THE TREE TO COLLAPSE ONTO EITHER DWELLINGS OR ADJACENT HIGHWAY.

T2 - COMMON BEECH - THIS TREE HAS A VERTICAL SPLIT ON THE SOUTH SIDE OF THE MAIN TRUNK. THE SPLIT HAS ALLOWED A SOFT ROT TO DEVELOP THROUGHOUT THE TRUNK. ALTHOUGH THE CROWN APPEARS HEALTHY AT THE MOMENT, IT IS ONLY A MATTER OF TIME BEFORE A SIGNIFICANT BOUGH FAILURE OCCURS. I FEEL IT PRUDENT TO REMOVE THIS TREE WHILE THE TEAM AND TRAFFIC MANAGEMENT ARE IN PLACE FOR T1.
