Final commercial recycling collection contracts have not been finalized yet and will be formally established prior to the commencement of business operations. 1. Nature of Effluent & Waste: Trade Effluent (Liquid): Wastewater generated strictly from the washing and hydro-bathing of dogs [source: 1.1.1]. It consists of water, organic dirt/mud, and diluted, non-toxic, biodegradable commercial pet shampoos [source: 1.1.2]. Trade Waste (Solid): Consists entirely of collected dog hair clippings, trimmed nails, and clean, empty plastic product containers/packaging [source: 1.1.2]. 2. Expected Volume: Liquid Effluent: Very low volume, operating strictly on an appointment-only basis capped at a maximum of 4 clients per day. This equates to an estimated discharge of less than 150 litres of wastewater per operating day.
Solid Waste:
Low volume, generating approximately 1 small bag of hair clippings and compressed packaging per week.
3. Means of Disposal:
Liquid Disposal: Effluent will be discharged into the public foul sewer network via the internal domestic connection [source: 1.1.1]. To protect the sewer from blockages, a commercial inline hair trap/strainer interceptor will be permanently fitted to the salon bath drains to catch gross solids and fine fur at the source [source: 1.3.6].
Solid Disposal: All solid hair clippings and packaging will be collected in a dedicated lidded internal bin [source: 1.1.5], transferred to a secure external commercial wheelie bin on site, and removed via a licensed commercial trade waste agreement [source: 1.1.2]
