Your proposal to render the existing brickwork and add wooden cladding to the front of the building will require planning permission as an assessment in respect of the impacts on visual amenity will need to be undertaken and the proposal relates to a commercial premises. The proposal will require full planning permission supported by a full planning application form and existing and proposed elevations amongst other documents to meet national and local validation requirements. This application type has an 8-week determination period upon submission of a valid application and a fee of £309.
