T1 - Damson Tree at front of property - Current Height 6m+ - Reshape and reduce by 30% - restricting light to property
T2 - Pear Tree at side of property - Current Height 6m+ - Reshape and reduce by 30% - restricting light to property
T3 - Cherry Tree at the side of property - Current Height 6m+ - Reshape and reduce by 30% - restricting light to property
T4 - Rowan Tree at side of property -Current Height 6m+ - Reshape and reduce by 30% - restricting light to property
T5 - Pear Tree close to boundary wall - Current Height 6m+ - Reshape and reduce by 30% - restricting light to property and causing damage to wall
T6 - Damson Tree -These trees are probably self-set, 11m in length, no major pruning works have been carried out to them. They are multi-stemmed and growing competitively with each other. The crowns are dense and there are lots of crossing branches present.
