I found that the only nursery care in the area is the school nurseries that are only open term time and from age 3. We are also aware of the development on doncaster road, taking this into consideration I'm eager to turn the 2nd half of the building (the church hall) into a private nursery class E. This proposed change of use would create a nursery place for roughly 40 children aged 0-5 years and create 8 jobs. The nursery would run 51 weeks out of the year excluding Christmas and operate between 7.30- 6pm, staggering pick up and drop off times to ease congestion of the already busy road and not to clash with school drop offs and collections.
