I have been informed by 'Salter Tree Services' (Arborist/Tree Surgeon), 11 Maythorne Close, Staincross, Mapplewell, Barnsley S75 6PF, that the aforementioned trees need a "crown lift to 4 metres" to maintain safe passage for any vehicles using the road into the Lakeside View estate.

The work carried out is for general maintenance (crown lift) for the residents of Lakeside View as the trees overhang the road used by the homeowners. The overall welfare of the trees will not be affected. Maintenance will be carried out to preserve the health of the trees. No other trees on the site under a TPO will be affected by the planned work.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
