## Description of Proposed Works

Please describe the proposed works

I would like to change the fence on 2 sides of my back garden from old wood, to composite plastic and raise it by approximately 0.8metre. My garden backs directly onto Sheffield road and is extremely noisy from buses, lorries and tractors that pass regular, which spoils my enjoyment, plus the houses opposite look directly into the garden, thus meaning i have little privacy, again spoiling the enjoyment to sit out - I feel that by raising the fence, it will offer some degree of privacy (should stop the direct line of sight from the upper windows of the houses opposite) and help reduce some of the noise from the larger vehicles, and by changing to composite, it should also help reduce the noise levels.

The house next door, which also backs on to Sheffield Road (2 Old Mill House) has already had their fence raised to this height, so I assume this shouldn't be an issue.

I would also like to put in a pedestrian gate, to allow my children access from the back garden to catch their school bus, as the rat run that is Lower Roughbirchworth Lane (and the speed of traffic on there) which they have to negotiate by going through the front and around to the back of the house, is a worry. These changes are only to and within the boundary of my property and wouldn't affect the enjoyment or natural light of others in the area.
