Explanation for Proposed Demolition Work

Why is it necessary to demolish all or part of the building(s) and/or structure(s)?

The existing single-storey extension is proposed to be removed to facilitate the construction of a high-quality replacement extension that better meets modern design, structural and Building Regulations standards. The replacement extension will incorporate new foundations, improved thermal performance, robust external wall construction and a new roof structure, ensuring the long-term sustainability and functionality of the building.

Whilst the existing extension has served its purpose, its removal provides an opportunity to deliver a more cohesive and sympathetic addition that better complements the character and appearance of the host property and wider Conservation Area.

In addition, the existing boundary treatment will be removed and replaced with a new natural stone boundary wall and timber fencing. This will provide a significant visual enhancement to the street scene and create a boundary treatment that is more reflective of the traditional materials and detailing found within the surrounding area, thereby helping to preserve and enhance the character and appearance of the Conservation Area.
