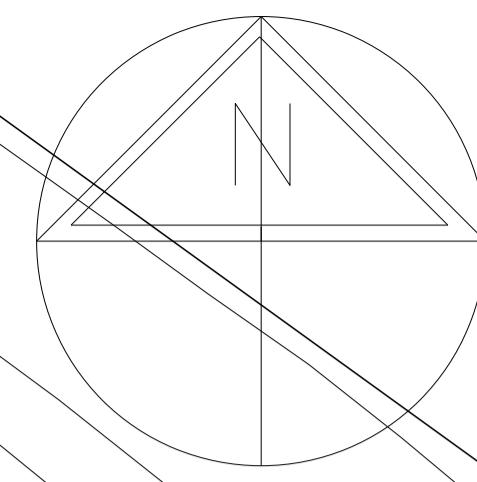

  - Easements to rear of Units
  - Pre-cast concrete paving slabs - 1200mm wide path.
