The house was fully renovated 6 years previously with the windows and front doors being replaced with new aluminium units, however the side door was left at this time. The current side door is a wooden, stable door with a single glazed unit in the upper portion, stained dark brown and is not in character with the rest of the house. I propose replacing this door with a new aluminium door with a central glazed window, the door would be coloured slate grey in line with the window frames of the house and the central window mimics the interior doors which have a similar design. There would be no structural work undertaken.
