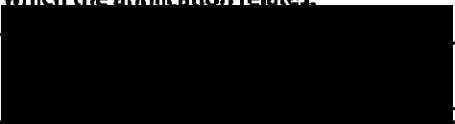
PROPOSED FLOOR PLAN AND ELEVATIONS - DRAWING N° 1
