Summary - The proposed extensions and front elevation dormers are likely to be considered acceptable. Should an application come forward, the rear elevation dormer window should be set back to be within the roof plane and not built off the rear elevation wall. A minimum of two parking spaces should be provided on-site. With these amendments, the proposal would be likely to be considered acceptable should an application be submitted.
