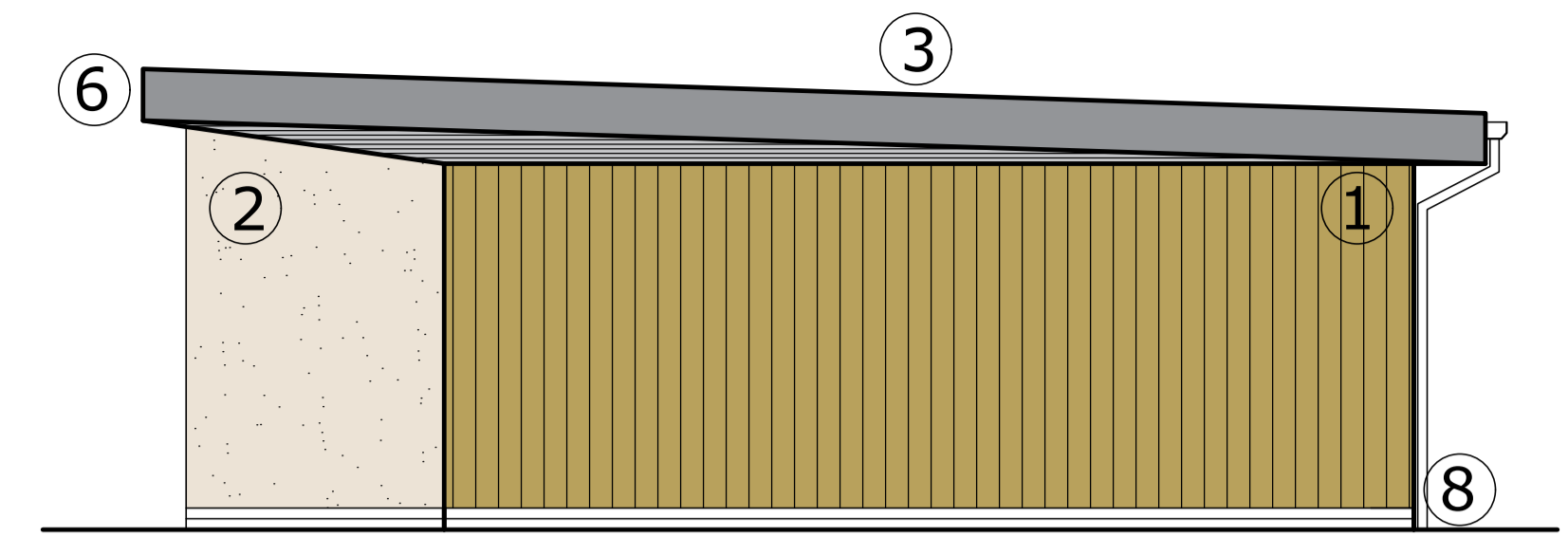
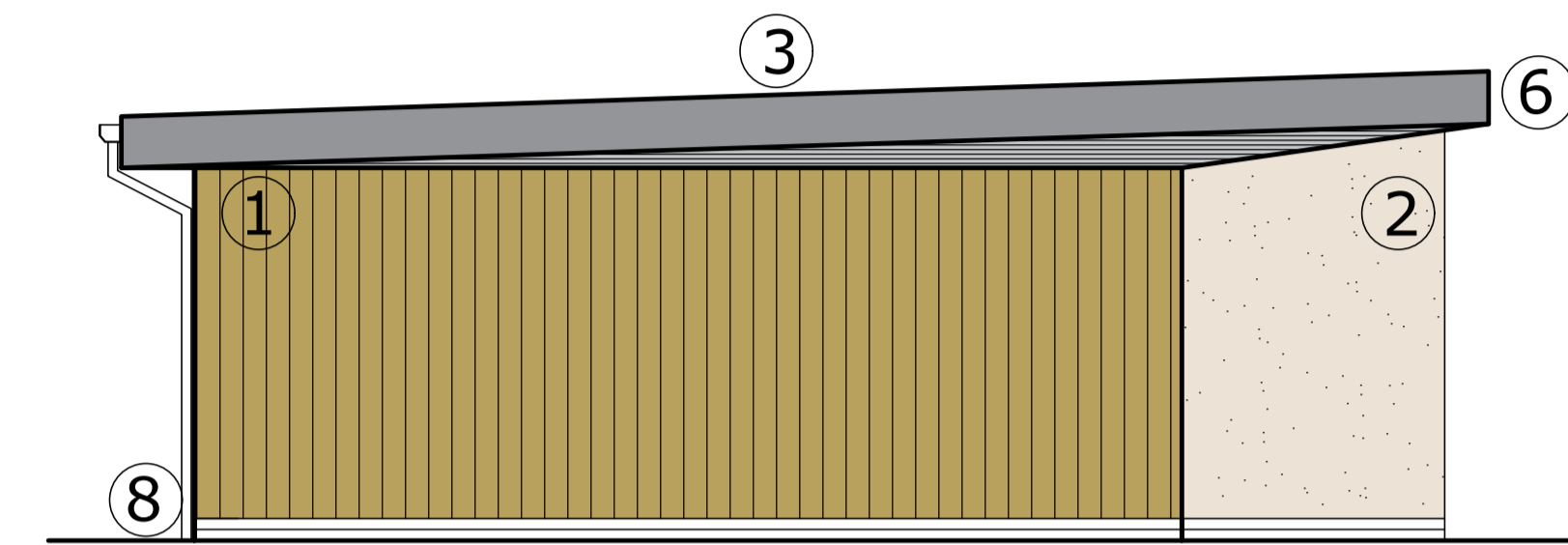


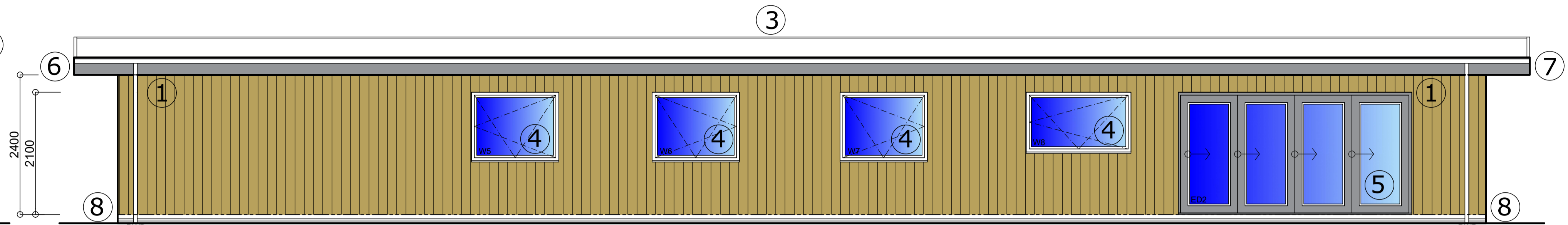
FRONT ELEVATION

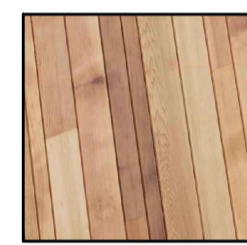
SIDE ELEVATION 2

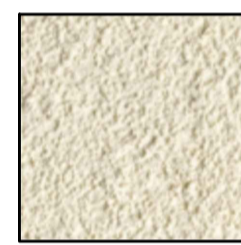

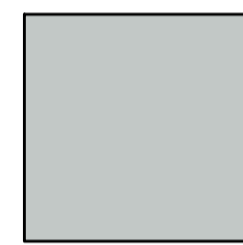

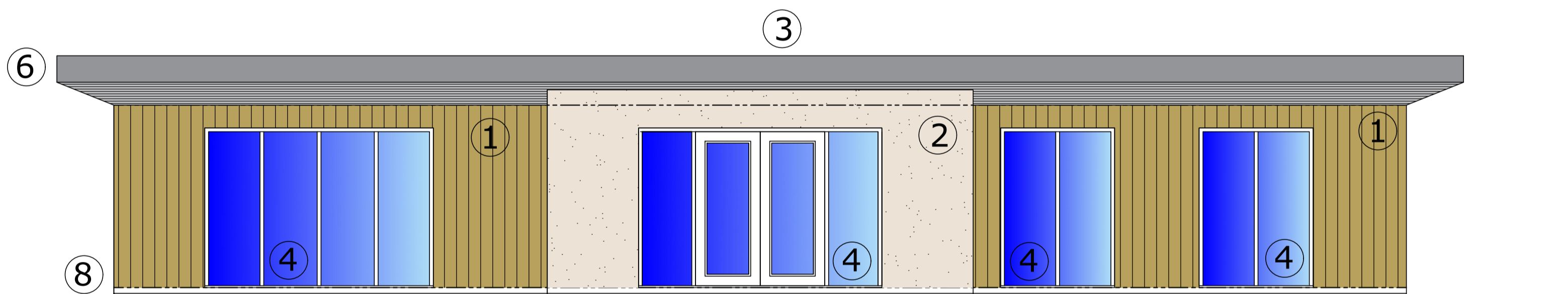

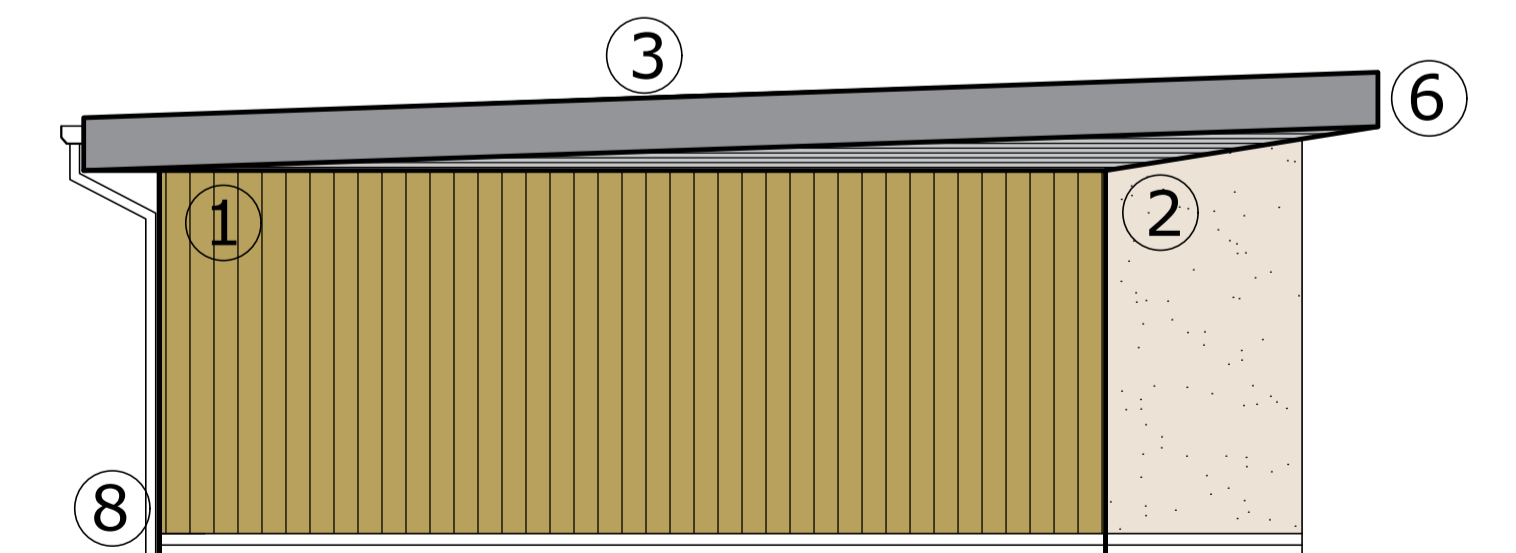

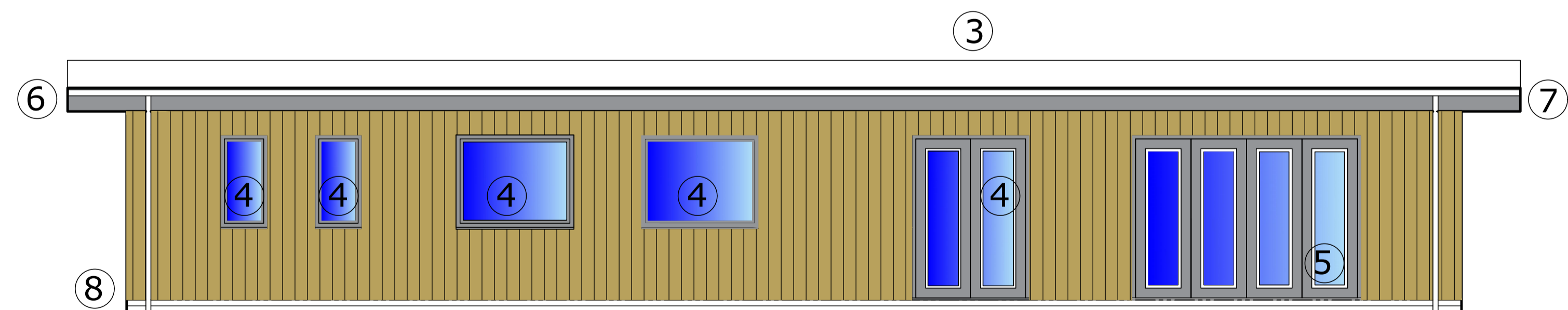
