3. Description of proposal

The woodfuel business has been operating for 5 years and is an emerging sector and is steadily growing. As a result a change of use application is now needed and additional storage for woodfuel. The proposal is for a site in Brierley, which is a strategic location close to suppliers and points of demand in Barnsley. This proposal is in two parts: Firstly a retrospective change of use application for yard space and storage land at the farm to be used for woodfuel storage. Secondly an application for the erection of a barn to store woodfuel.

Description of Application: Change of use.

Please see plan 1 (current use) Silvapower is a woodfuel production and supply company established in 2004. At that time, Silvapower established a woodfuel storage area at Ringstone Hill Farm with the aim of providing a storage area close to new boilers. In addition the project provides a farm diversification opportunity through provision of woodchip delivery services. The farm business currently provides storage services on a former paddock area (A) and a field area (B) behind a barn. At the time Silvapower approached Barnsley Planning department and the view at the time from Mr Bob Meriwether was that a change of use application was not necessary. However, as time has moved on, the scale of the operation has changed such that the current view is that a change of use application is now appropriate.

The current change of use application seeks permission to store woodchip and timber on the former paddock area and a field area: Plan 2(A) and (C). Area C is equivalent in surface area to Area B, however Area B has proved to be unsuitable and will be returned to field use. The nature Log piles are naturalistic in appearance and woodchip is stored under a green poly felt material which blends into the agricultural setting. The current operation has taken place on the highlighted areas for a period of 5 years without any complaints or comments.

Description of Application: Erection of Agricultural Barn for storage of Woodfuel.

Please see plan 2. The application seeks permission to erect an agricultural style barn for the storage of woodchip in the area marked. The current storage arrangements are inadequate for the regional woodfuel industry and for Silvapower Ltd. A woodfuel storage barn is essential to meet the needs of the emerging market for high quality woodchip in terms of low moisture content and absence of contamination. The proposal is for a woodfuel storage barn of 100' * 60' (approx 30m * 18m) and associated operating apron. The storage barn will ensure woodchips can be supplied reliably to the new CEN standard for woodfuel. The site is in a windy location – permitting exceptional passive drying of woodfuel material, thereby lowering its moisture content and enhancing its environmental performance.

Plan 3 shows the proposal in cross section. The proposed building roof level will be no higher than existing barn buildings. The proposed building is set slightly into the gradient of the site. Viewed from the road the existing backdrop of agricultural buildings screened by trees would be replaced by a similar backdrop of a new barn similarly screened. The new barn is proposed to be of typical agricultural construction. The lower sections are of concrete panels, consistent with existing buildings on the site, and which will age over time to blend with the existing buildings. The upper sections will be clad and coloured green to blend into the agricultural setting. The roof is to be of a

material consistent with existing buildings, which will also 'age' to blend in. Adjacent to the existing workshop are a line of Silver Birch trees, planted by the farmer which has matured to form a pleasant screening feature. A similar scheme is proposed for the new barn as highlighted on Plan 3.

An alternative sites at this location has been considered within the immediate farm yard boundary notably the paddock area. However, this area has had to be rejected due to the presence of a significant number of drains and water supply pipes stemming from the Yorkshire Water reservoir next door (Plan 4). Some of the pipes have exclusion zones prohibiting development around them. The number and position of these pipes makes this site unusable for the barn.

Alternative storage in the form of industrial space has been investigated in collaboration with the South Yorkshire Forest Partnership. The result of this extensive exercise covering some 34 sites was that the cost of industrial space was prohibitive and would make the business unviable.

Reason for Application

The Renewable energy market in S Yorkshire and nationally is growing. The current woodfuel operation employs 2 people full time at Silvapower and 2 people on a part time basis at the farm business. By sourcing timber locally it is providing a new market for low grade timber for local woodland owners and local forestry contractors, each of which contributes to the local economy. PPS7 Sustainable Development in Rural Areas supports development that delivers diverse and sustainable farming enterprises.

The UK Renewable Energy Strategy (RES), published in July 2009, set out a path towards achieving the UK's target of sourcing 15% of overall energy consumption from renewable sources by 2020. The lead scenario set out in the RES suggests that 12% of heat demand could come from renewable sources.

The proposed project will enable woodfuel to be delivered at a lower moisture content. This has a number of important benefits. Firstly the energy content per delivery is increased, this has the effect of reducing the number of delivery journeys made thereby reducing traffic levels. Secondly it results in higher energy output per tonne of timber, thereby making more efficient use of regional timber supplies and further reducing traffic in the form of raw material deliveries.

Heat sourced from woodchip fuel is classed as 'carbon neutral' this having no negative impacts on the climate. By replacing use of fossil fuels with renewable woodfuel carbon emissions savings of 90% can be achieved. Renewable heat installations, such as those used by Barnsley Council are having a positive impact on reducing green house gas emissions. PPS22 Renewable Energy, suggests that very special circumstances may include the wider environmental benefits associated with increased production of energy from renewable sources. We believe that this positive impact on the climate is 'a very special circumstance' and as such this farm diversification scheme should be allowed.
