- T6 - Sycamore, remove deadwood stub and hanging branch.
- T13 - Ash, Re-pollard to a lower height approx 5m
- T27 - Ash, Reduce 2 stems to lower points (each by 2m approx), thereby removing existing regrowth and the decaying stems.
- T28 - Beech, Fell tree, (tree has had a felling cut near base, this has been colonised by decay fungi)
- T31 - Ash, Remove large limb facing north, at 9m with the split cavity, the client would like this removing, rather than shortening. The client is concerned about the branch.
- T41 - Sycamore, fell tree, leave standing stem. Much damaged and necrotic bark on lower half of stem.
- T43 - Sycamore, fell tree, tree has suffered fire damage, ongoing decrease in safety of tree.
- T46 - Beech, fell tree, leave standing stem 4m. bark damage, wood quality in decline throughout lower stem.
- T50, Lime, shorten the major westerly limb to growth points directly above boundary wall.
- T52, Beech, reduce major southern limb by app 3m at all branch ends. Reduce high southern canopy by at least 2m.
- T55, Sycamore, fell tree, very severe lean over road, very poor form with poor future likely.
