The proposal will be situated within the existing boundary of 15 Collier Way Mapplewell Barnsley S75 6GJ. The size of the proposal will be 5m x 3m and will be no more than 2.5m high from the highest point of ground. The proposal will be used for leisure (gym/ office) and will be supplied with electricity and an internet connection. The construction will be of steel ground screws (to minimise ground disturbance) to an acceptable depth and the building will be built from a steel frame, boarded with timber OSB, cladded with composite boards. Internally will be a plastered finish with heating and bifold doors. All access arrangements will remain the same as the building will be position in the rear garden of the existing property boundary.
