Installation of commemorative plaque on the ashlar dressed stone exterior wall of Queen's Business Court, formerly Queen's Hotel, facing Regent St. Historic England Listing 1286809

It will be positioned at a height of 2.9 metres, on the wall to the side of the portico, horizontally centred (at 360mm), above the existing Queen's Court Business Centre signage, near the carved heads of Catherine Mawer and Benjamin Payler.

The plaque is made of cast aluminium with a painted blue background and raised white lettering. It is 18 inch (455mm) in diameter with 15mm & 18mm text (5/8" and 7/8"). It is to be fixed by stainless steel screws in the mortar joints using drilled countersunk fixing holes. The screw heads will be covered with matching paint.
