Please describe the proposals to alter, extend or demolish the listed building(s):

Installation of a commemorative plaque on the dressed stone exterior wall of 14 Regent Street facing Regent Street, Historic England Listing 1191936.

It will be positioned at a height of 2.5 metres, on the wall between the gateway and the columned doorway, horizontally centred (at 350mm), above the existing signage.

The plaque is made of cast aluminium with a painted blue background and raised white lettering. It is 18 inch (455mm) in diameter with 15mm & 18mm text (5/8" and 7/8").

It is to be fixed by stainless steel screws in the mortar joints using drilled countersunk fixing holes. The screw heads will be covered with matching paint.
