Ash (*Fraxinus excelsior*) located in the rear garden of Nr.3 Delf Garth. The tree has been getting less and less leaf coverage over the past couple of years and upon inspection shows sever signs of decay, with numerous dead branches. Leaf cover this year is very thin, and the owners would like to remove the tree completely, before it becomes unsafe and causes property damage, and replace it. The tree is part of a group of trees under TPO with Reference number 8. Tree reference nr. A1 (Area of Chestnut, sycamore, BNeech, Elm, Ash and Oak) status 0.

The owners would be happy to replace with another tree suitable to location and fitting with what is already protected such as chestnut, oak or beech (although the first 2 may be more suitable for South Yorkshire) or also happy to be guided by the council if they have a preferred species.

Hawthorne (*Crataegus monogyna*) located in the bottom corner of the plot, in good health although there is evidence of a few branches having been removed with some occlusion there is no real good shape to the tree. Suspect it is self seeded and of little amenity value. Owners would like to plant up new trees and shrubs to redefine the boundary of their property.
