Creation of a secure storage compound to the side and rear of the telephone exchange. The storage area is to be used by the civil team and will house materials and equipment to support the local telecoms infrastructure network. The compound will have two 6m containers sited to hold the equipment and allow teams to deploy efficiently throughout the area. The Government has set a target to connect a minimum of 85% of premises to gigabit-capable coverage by 2025. This is a huge infrastructure upgrade for the UK and one that will generate considerable benefits to both the economy and society. Having a regional network of containers/sites is the least disruptive, most efficient and environmentally sensitive way to support the required rate of rollout - as it minimizes the travel required whilst maximizing the time available to build the new network.
