- T5 : HORSE CHESTNUT REMOVED AS DAMAGING HIGHWAY RETAINING WALL
- T6 : OAK : TO BE RETAINED.
- T7 : OAK : TO BE RETAINED.

It is proposed all trees apart from the oak trees are removed due to damaging the highway retaining wall (please refer to our structural engineers wall report on this matter), It is the clients intention to repair the wall to do this he will need to take the existing wall down and batter the retained earth to the

rear of the wall for access for safe working, this will no doubt cause any trees near the wall to to become unstable and/or cause damage to tree root systems.

Our tree consultant advisers that T1 to T5 should be removed as these are causing damage to the highway wall, please refer to there report for more information.

The applicant would not be opposed to planting replacement trees within the site away from the retaining wall to stop this happening again in the future.
