# DESIGN & ACCESS STATEMENT

## Instructions

Instructions were received from Messrs JR & JE Griffiths to consider the proposal for a roofing over a silage clamp and a new storage building at Gunthwaite Hall Farm and to provide a Design & Access Statement

## Layout

The proposed farm buildings are located adjacent to the existing farm yard to the south east of the existing buildings which lies at the centre of the land holding in the parish. This location is proposed given its central location within the land holding, and the existing partial screening from the farm buildings.

## Scale

The proposed storage building is a structure of 18.28 x 9.14m which is considered to be of sufficient size to contain the feedstuffs reasonably necessary for the agricultural operations on the holding. The silage clamp roof is a structure of 27.74 x 10.28m which is considered to be of sufficient size to contain the silage reasonably necessary for the agricultural operations on the holding when combined with application number: 2023/1024. There is a justifiable agricultural need for a building on the site and proposal is considered to be the minimum size required.

## Landscaping

The application does not include landscaping by way of hedgerow and tree planting. The location of the proposed buildings will utilise the existing buildings to the north west to screen the development while siting it adjacent to the buildings will limit its impact on the surrounding landscape.

## Appearance

The proposed silage clamp will be constructed of a steel portal frame and clad on the south, and north elevations with concrete panels with profile metal sheet cladding above. The roof will be constructed of anthracite grey fibre cement profile sheeting. The building will be left open fronted to the west.

The proposed storage building will be constructed of a mono pitched steel frame and clad on the north, east and west elevations with concrete panels and profile metal sheet cladding above. The

roof will be constructed of anthracite grey fibre cement profile sheeting. The building will be left open fronted to the south.

The use of profile metal sheets will allow the building to blend into its surroundings. Fibre cement roof sheets quickly blend into the countryside, turning dark green over time to blend into the surroundings.

### **Access**

The site will be accessed off the existing farm yard from Gunthwaite Lane which runs from Upper Denby, to the north west of the site. There is a yard running from the tarmac road to the silage clamp and storage building, this will be utilised to access the proposed building.

### **Summary**

In summary, the proposal is considered suitable in terms of layout, scale, landscaping, appearance and access.
