Further to our recent discussions in connection with the above site. please find attached, on behalf of our mutual client, information as listed below being a formal Full Application under the Town and Country Planning Act.

At present we believe the land in question is within an area zoned for residential purposes and our mutual client has obtained a formal agreement from Barnsley MBC to demolish the existing natural stone built redundant property - which is located to the rear of the site and is in very poor state of repair – and erect 2 no. proposed detached dwellings to the front each with detached double garages.

Both these proposed dwellings will be constructed in natural stone with grey colour flat profiled concrete interlocking tiles – ditto the 2 no. detached double garages.

Also note that there will be min. 5 no. car parking spaces – including 2 within each garage – thus ensuring more than adequate spaces for both residents and visitors.

The site will be accessed from a single re-located central shared driveway at 4.0m wide – this serving both properties.



The location of these proposed dwellings -- located further towards Hoyland Road than the existing building to be demolished -- will ensure adequate rear private amenity areas for both of these properties.

Also the detached garage positions, now located further away from the front boundary abutting Hoyland Road - as requested by yourselves - will also enable to retain various established trees, shrubs and hedges to this front area which will help to both soften and screen the proposed development.



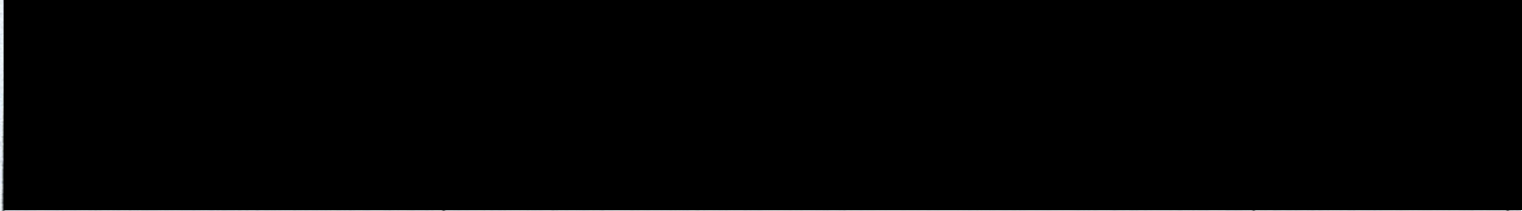
