I write with regard to your proposal for a multi-purpose retail and eatery establishment at 9 Peel Parade in Barnsley Town Centre. Apologies for the delay in responding to you.

The proposal seeks to amend the use of the premises from an A4 drinking establishment to a mixed use eatery at the first floor with retail/leisure units below. The change of use is proposed within the Westgate/Churchfields district of the town centre where shops, leisure and entertainment uses are acceptable in line with the proposals suggested by yourself. Similarly the building is set across a designated secondary retail frontage which accommodates for the retail and leisure uses suggested.

The first floor eatery would not require an application as it is covered under Section AA of Part 3 of the GPDO which allows drinking establishments to provide expanded food provision as permitted development. I will however advise that indoor cooking is likely to require a means of extraction for cooking fumes, indications of washing facilities for food preparation areas as well as locations for storing food in a safe manner i.e. fridges and freezers and a means of cleaning utensils and crockery appropriately i.e. dishwashing. Your tenants will need to be made aware of these provisions.

The uses proposed at the ground floor are somewhat complicated as they would require the following use classes:

- Yoga Studio – D2
- Clothing Boutique – A1
- Masseur's Studio – D1
- Photographers Studio – Sui Generis
- Body Piercing/Tattoo Studio – Sui Generis
- Record Shop – A1
- Café – A3

It will be possible to provide the units with a mixed A1/A3/D1/D2 use dependent on the tenant but a Sui Generis use is specific to a given use. I.e. a Sui Generis Tattoo Parlour cannot then be used as an A1 record shop should a tenant find another premises when expanding. This would then require a change of use planning application from the Sui Generis use to another use, whatever that may be, which would incur time and expense to yourself while delaying the new tenant from operating. The flexible use across A1/A3/D1/D2 would cater for most uses barring the Sui Generis use outlined. I would therefore suggest you submit an application for a change of use of the ground floor of the premises to a flexible A1/C3/D1/D2 use (A1 being mostly interchangeable with A3 and D2 in relation to permitted development rights) and should Sui Generis uses come forward, they submit applications as the tenant.

Overall I can state that the proposal would be considered favourably based upon the information available at the present time.
