In line with a previous application (2013/0050) for which works were not carried out in their entirety I would like to apply for works to be carried out on 3 trees situated in the property of number 47 Bowden Grove with permission sought and granted from that properties owners.

The trees, seen in the attached diagram / sketch are numbered 1 (Poplar), 2 (Sycamore) & 3 (Sycamore). The request is to crown clean each tree, remove any dead or damaged branches as well as any foreign objects. There will also be thinning to the density of the trees by 20%.

This is to remove the current excessive shading of properties 4, 6, 8 & 10 Langford Close situated to the South of these trees. Said properties also suffer from overhanging branches from these 3 trees.
