Dear Jack

Change of use to form bar and gymnasium from solarium and gymnasium. Unit 1a, St Andrews Square, Bolton Upon Dearne.

I visited the site and was told that one room would be used as a bar but that the remainder of the gymnasium would be retained. This is shopping parade with a range uses including take away food. However, the upper floors are in residential use and rtherre have been complaints about noise and smells from takeaways in the past.

I have received the following comments from Pollution Control. There would be concerns regarding noise, from chiller units that may need to be installed. Noise from deliveries and patrons leaving the premises would also be a concern. There would therefore be restrictions imposed on opening hours and times of deliveries. You would need to provide details of any chiller units.

Parking is available on street and at the rear so there are no objections raised by highways.

If you decide to make a planning application for change of use of part of the building to a bar it likely that in addition to the above this would be made personal to you and that the area of the bar would be controlled. Internal floor plans indicating the area of the bar would be essential.
