The proposal consists of a single-storey rear extension to an existing semi-detached dwelling, with the developed area around the property not exceeding 50%, with a depth as measured from the existing rear wall of the property not exceeding 3.0m, with an eaves height of no greater than 3.0m as within 2.0m of the boundary and overall not exceeding 4.0m at any point. The proposals do not include any verandas, antennae, chimneys, flue, soil pipes. There are no alterations to the existing roof of the existing property. The property is not on designated lane. The materials proposed, buff brick, are of a similar appearance to those of the current rear elevations, buff brick.
