The application comprises 3 separate elements within the existing Peak Venture site:

1. Proposed reception building and staff room - these are to be located within the former maintenance compound adjacent to the rear carpark. The compound comprises 4 existing storage containers within which maintenance equipment and spares for adventure facilities equipment are stored, all contained within a fenced 1.8m high close boarded timber enclosure, accessed by vehicular gates
2. Quad bikes extension (8 x 24m) and small container (6 x 3m) for storage and maintenance of quad bikes - these are to be located within part of the plantation woodland towards the northern edge of the site
3. Garage building - to be located within the grassed amenity area to the southeast of the approved pods and lodges, adjacent to the repositioned existing garage and shed buildings.
