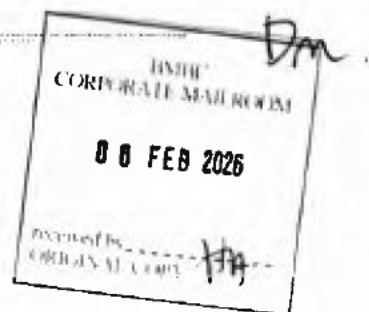

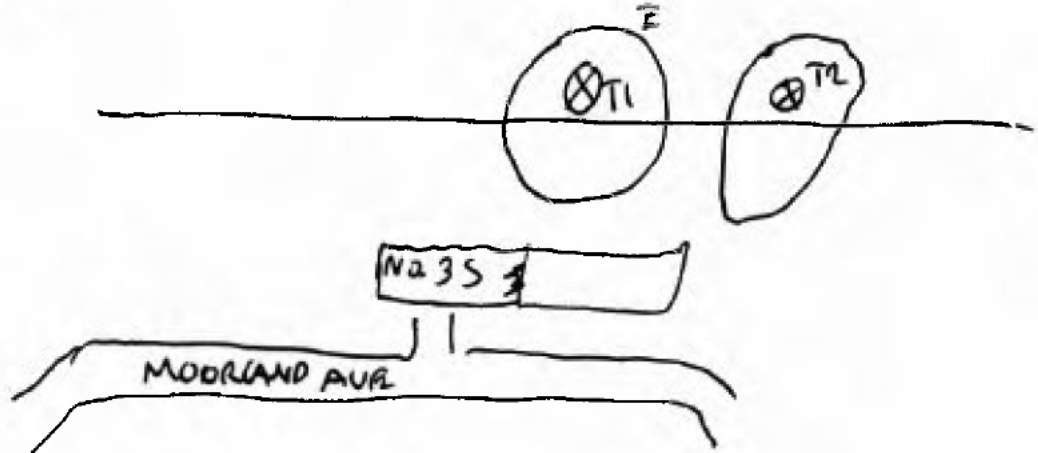

T1 & T2 ARE GROWING TOWARDS THE NATURAL SUNLIGHT OF MR. JOYCE'S GARDEN AND ALMOST REACHING THE PROPERTY. HE HAS REQUESTED THAT A PROFESSIONAL ARBORIST CARRY OUT THE WORK TO CROWN LIFT THE TREES TO APPRAISE THE PROBLEM. BOTH TREES ARE TO BE CROWN LIFTED TO SM HEIGHT WITH CUT DIAMETERS < 20 CM AND DONE IN ACCORDANCE WITH BS 3948:2010. THE WORKS WILL ALLOW MY CLIENTS USE OF THEIR GARDEN WITHOUT PROBLEMS CAUSED BY LONG LOWER BRANCHES GROWING INTO THEIR GARDEN AND NEAR THEIR PROPERTY.
