##### Site

The subject property is situated approximately 7 miles to the south west of Barnsley town centre within the Wentworth Industrial Estate on Maple Way. Wentworth Industrial Estate has been developed around the main estate spine road of Wentworth Way and links directly to the A616 Stocksbridge Road, which provides a direct route to the M1 motorway at Junction 36 approximately 1 mile to the east. Wentworth Industrial Estate accommodates mainly industrial uses with occupiers such as HSBC, Company Shop, Daimler Chrysler, South Yorkshire Fire Rescue, Cranes UK, Jacquet UK, AG Glass and Glazing Ltd, Volvo and iTAB The property is accessed off Maple Way which leads directly onto Wentworth Way and is located to the front of the industrial estate, bounded on the southern side by the A616 Stockbridge Road. The eastern boundary is formed by an industrial / warehouse unit occupied by iTAB and the western boundary by a HSBC's South Yorkshire National Data Centre (SYNDC).

The property was built in the 1990s and is of steel portal framed construction and comprises a two storey office facility. Internally the property benefits from a reception area with the office space at both ground and first floor level fitted out to a modern specification offering a variety of open plan and individual office suites.

Externally the property is situated within landscaped grounds on a fully secure site with barrier controlled access and dedicated surface car parking for approximately 270 vehicles.

The building previously accommodated AECOM Design and Build Limited and, as such, has a B1 use.

##### Proposal

The proposed use of the site would enable Haslam Transport to operate their haulage business. The business comprises hiring Concrete Wagons to the construction industry – It has been stated that no concrete mixing would take place on site. The details submitted with the pre application enquiry are relatively brief and further information regarding the business operations would have been helpful to provide more detailed comments/advice.

However, having considered the proposed description of the operations on the site, and, having consulted both the Land Use Gazetteer and 'A Practical Guide to Permitted Changes of Use', I can confirm that the use would be considered 'Sui Generis' or 'a use of its own kind'. As there is no permitted change from B1 to Sui Generis a change of use planning application would be required in this instance.

##### Considerations

As the proposed use would be a commercial/industrial use on a business/industrial estate then there would be no objection in principle to the proposal. I have consulted colleagues in Enterprising Barnsley 'a key partnership of key organisations involved with economic development and regeneration of the Barnsley area' regarding alternative uses of the site and they have not raised concern with further employment
