



— UPGRADES TO RETAIL UNITS TO THE NORTH-WEST GROUND FLOOR FAÇADE FORM PART OF SEPARATE PLANNING APPLICATION. SEE DR-A-3600 DRAWING SERIES FOR DETAILS

— NEW CONFIGURATION TO RETAIL UNIT FRONTAGES, ESPECIALLY RELOCATION OF ENTRANCE DOORS, TO ENABLE LEVEL ACCESS TO INTERIOR OF SHOPS AS FAR AS POSSIBLE WITHOUT ADDITIONAL LANDSCAPING WORK TO THE EXTERNAL HARDSTANDING. NEW CONDITION AT DOOR THRESHOLD FOLLOWING COMPLETION OF UPGRADE WORKS TO BE NO WORSE THAN EXISTING CONDITION
