e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sycamore Tree number 31 Restricts the visibility of vehicles travelling from the left when leaving the driveway. To see traffic coming from the left it is necessary to drive the car forward from the drive into the road. When there is no traffic coming from the right this is possible but we have had several near misses when cars have been overtaking parked vehicles on the lane and taking a position on the opposite side of the road.

The drive access is too narrow to enter from the road without pulling wide into the oncoming line of traffic. We have issues with drivers trying to undertake before we turn ignoring indicators signifying the intent to turn left. On one recent occasion a motorcycle attempted to undertake our vehicle and collided with our car damaging the passenger door. Luckily no one was hurt. Consequently we now want to widen our drive entry to facilitate safer entry and exit to our home. The drive cannot be widened without removal of the tree.

Smithies lane is now very busy with traffic at all times of day but at peak times entry and exit from our drive is very difficult.
