The proposal comprises the change of use of the upper floors of the existing building from Class E (commercial) to Class C3 (residential), to facilitate the creation of self-contained residential accommodation.

The ground floor commercial use is retained. Minor alterations are proposed to the existing shopfront, including replacement of signage and associated external detailing.

Associated works include minor internal alterations, limited external alterations to the rear elevation, provision of two on-site car parking spaces with an electric vehicle charging point, and the inclusion of secure cycle storage.
