



REFUSAL OF PLANNING PERMISSION

TOWN AND COUNTRY PLANNING ACT 1990

Proposal Erection of detached bungalow and associated works

At Land to the rear of 29 Station Road, Lundwood, Barnsley, S71 5LD

Permission is **refused** for the proposals which were the subject of the Application and Plans registered by the Council on 28/10/2020 and described above.

The reasons for the Council's decision to refuse planning permission are:

1. In the opinion of the Local Planning Authority, the proposed development would be contrary to the Local Plan policies GD1 'General Development, D1 High Quality Design and Placemaking and the SPD Design of Housing Development in that it would be an isolated and incongruous form of backland development that would be harmful the amenities of surrounding properties and character of the area due to its location that runs counter to the prevailing street pattern.
2. The proposal is a 'garden grab' development that would remove the majority of 29 Station Road's external amenity space thereby permanently reducing the quality of amenity enjoyed by existing and future residents of 29 Station Road contrary to the SPD Design of Housing Development and Local Plan Policies H9 - The Protection of Larger Dwellinghouses and GD1 - General Development
3. The siting of the proposed dwelling would be materially detrimental to the amenity of 31 Station Road by reason of its overshadowing impact while being injurious to the privacy of future occupants of the proposed dwelling through insufficient external separation distances from 29 Station Road contrary to the SPD Design of Housing Development and Local Plan Policy GD1 - General Development.
4. The proposal lacks sufficient internal space to provide an adequate level of amenity for future occupants required by the minimum standards outlined within the South Yorkshire Residential Design Guide which accord with the amenity requirements set out in the SPD Design of Housing Development and Local Plan Policy GD1 - General Development.

Pursuant to article 31(1)(cc) of the Town and Country Planning (Development Management Procedure) Order 2010 (as amended), the Local Planning Authority have, where possible, made a pre-application advice service available, complied with our Planning Service Charter for Business and otherwise actively engaged with the applicant in dealing with the application.

Please be aware that the Council monitors construction sites and open land within the vicinity such sites in an attempt to prevent fly tipping (i.e. unauthorised deposit of waste on land), which is illegal under the Environmental Protection Act 1990. The penalties for fly-tipping can include:

- a fine of up to £50,000 and*
- up to six months imprisonment on conviction.*

Therefore, if necessary, please ensure that all demolition waste and waste associated with the construction of the approved development is disposed of via approved methods and that documents are retained to prove this.

Appeals to the Secretary of State

If you are aggrieved by the decision of your local planning authority to refuse permission for the proposed development or to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.

If you want to appeal against your local planning authority's decision then you must do so within 6 months of the date of this notice.

The Secretary of State can allow a longer period for giving notice of an appeal but will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.

The Secretary of State need not consider an appeal if it seems to the Secretary of State that the local planning authority could not have granted planning permission for the proposed development or could not have granted it without the conditions they imposed, having regard to the statutory requirements, to the provisions of any development order and to any directions given under a development order.

If you intend to submit an appeal that you would like examined by inquiry then you must notify the Local Planning Authority and Planning Inspectorate (inquiryappeals@planninginspectorate.gov.uk) at least 10 days before submitting the appeal. Further details are on GOV.UK.

Purchase Notices

If either the Local Planning Authority or the Secretary of State for the Environment, Transport and Regions refuses permission to develop land or grants it subject to conditions, the owner may claim that he can neither put the land to a reasonably beneficial use in its existing state nor can he render the land capable of a reasonably beneficial use by the carrying out of any development which has been or would be permitted. In these circumstances, the owner may serve a purchase notice on the Council in whose area the land is situated. This notice will require the Council to purchase his interest in the land in accordance with the provisions of part VI of the Town and Country Planning Act 1990.

Compensation

In certain circumstances compensation may be claimed from the Local Planning Authority if permission is refused or granted subject to conditions by the Secretary of State on appeal or on reference to the application to him. These circumstances are set out in Sections 114 and related provisions of the Town and Country Planning Act 1990.
