Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We have a large garden and in recent storms one of the trees (number 9) on sketch fell down luckily avoiding huge damage but if had fallen other way would have caused untold damage. We had no warning that this tree was dangerous. As it fell it took two huge branches off tree number 8, which on seeing it my tree surgeon advised it is now dangerous and would most probaby die to the nature of the injurty to it. It was also outlined to us that tree number 10 could well now be dangerous as is located extremely close to houses. This is because of the nature of the draining of the land.

May i explain that a few years ago and due to leak of over a year old it caused mine and next doors gardens to become saturated where the trees are. Number 88 next door also had a number of tpo trees which have subsequently been feel due to becoming dangerous due to the waterlogging.

It is feared now that this is whats happened in my garden .

I am now requesting that urgent permission is given to not fully fell these trees but to take them down to a safe level ie at least 50% for tree 10 and for tree 8 to take down to the injury in the hope that it will reestablish itself.

I would also ask for a site visit if necessary to ascertain whether the tpos on the other trees are necessary given the nature of the land now.

Tree number 8 is a oak and tree number 10 is an ash

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
