Thank you for the email below and sharing the proposed development plans.

We do have some concerns regarding the number of developments in the area and implications for access to Primary Care. Although this is not a large-scale development, other large-scale developments have already been agreed across Hoyland, Wombwell and Darfield and therefore this development has the potential to further increase the pressures that GP practices within those localities will be under as a result of the other developments.

Previously when we have received planning applications, we have asked that they are also shared with other NHS organisations such as Barnsley Hospital NHS Foundation Trust, South West Yorkshire NHS Foundation Trust and Yorkshire Ambulance Service, and we have shared the relevant contact details of individuals within these organisations.
