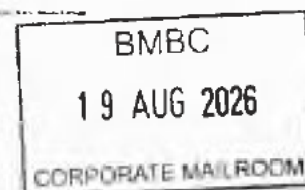

IN PARTICULAR, SYCAMORE TREE (T2) NOW OVERHANGS A
GLASS CANOPY. A NUMBER OF BRANCHES HAVE BROKEN
AWAY THIS YEAR IN HIGH WINDS; AND THERE IS CONCERN
OVER THE DANGER THIS REPRESENTS.
