4 extremely large trees under a TPO are in my garden and parking area. The trees have not been looked after properly and have become overgrown causing potential damage to the street (vehicle and pedeatrian) as the risk of falling branches increases. During recent poor weather two trees have dropped very large branches from near the top and are showing signs to lose several more branches. One is currently only held up by another branxh and hangs above my parking space.

I would like permission to have the trees trimmed back to ensure safety and continued growth of the trees over time.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
