It is acknowledged that the outbuilding proposed for conversion is an existing building and that entrance would provide a link, and gives association between the annex and the main dwelling, however it is felt that there is little justification for the large utility/boot room and should be removed from any subsequent planning application to limit the increase in floor area over and above 100% of the original floor area.

I also have some concerns that the conversion of the annex would result in the garden area associated with the property being cut off from use by the main dwelling and I would therefore suggest that the link between the main house and the garden area is looked into prior to the submission of a formal application.
