Tree Surgery Proposal

Property Address: 2 Kay's Terrace, Stairfoot

Proposed Works: Maintenance and Crown Management of 13 Trees

1. Executive Summary

This proposal outlines the necessary arboricultural maintenance for 13 specimen trees located within the grounds of 2 Kay's Terrace. The primary objective is to manage the size and density of the canopy to improve light penetration, ensure structural integrity, and maintain clearance for pedestrians and vehicles.

2. Scope of Works

The following specifications apply to all 13 trees identified for treatment:

Crown Reduction (25%)

Action: All trees will undergo a volume reduction of approximately 25%. Or potentially coppice the trees to 50% from current volume

Purpose: To reduce the overall height and spread of the canopy while maintaining the natural shape and silhouette of the species.

Method: Pruning back to suitable growth points (lateral branches) to minimize stress on the trees and prevent excessive regrowth.

General Thinning & Epicormic Growth Removal

Action: Selective removal of epicormic growth (small, "suckering" shoots growing from the main trunk or base) and internal crossing branches.

Purpose: To improve airflow through the canopy and reduce the risk of pests and diseases. This also improves the aesthetic clarity of the tree's structure.

Crown Lift (to 6 Meters)

Action: Removal of the lowest secondary branches to achieve a uniform clear stem height of 6 meters from ground level.

Purpose: To provide necessary clearance for the property, pathways, and any adjacent highways, ensuring the "dead space" beneath the canopy is functional.

3. Standards and Safety

BS 3998:2010: All pruning will be carried out in strict accordance with the British Standard for Tree Work – Recommendations.

Site Management: The work area will be cordoned off to ensure the safety of residents and the public.

Waste Removal: All arisings (branches and debris) will be chipped and removed from the site, leaving the property in a clean and tidy condition.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- Proposals for planting replacement trees (including quantity, species, position and size) or reasons for not wanting to replant.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
