We would like to apply for the permanent sighting of the portable classroom unit that was placed on the site under Application 2013/0699. I attended Barnsley MBC Planning Drop-In on Friday 13th March 2020 at 09:00 to discuss another application (2020/0335) with a Planning Officer. During our discussion, I was advised that that the planning for this portable classroom had lapsed and we needed to apply for full consent.

In addition, we would also like to apply for planning permission for a Road Traffic Collision (RTC) compound to be constructed on the site. The proposed compound would be in the area behind the existing training tower and would facilitate the on-site training of fire fighters in attending road traffic collisions. The proposed compound would be in the form of Herras fencing and gates along the red lines on the attached drawing.

With regards to 'Has the work or change of use already started?' the portable classroom remains on site from the original application however the RTC compound has not been built hence answering 'no' to this question.

With regards to questions related to contamination - all the vehicles used in the training scenarios are 'end of life vehicles' and come from an Environment Agency approved supplier. The vehicles are all de-polluted of all fluids and have their batteries etc. removed. These are then delivered to the station by the supplier. Once we have finished with them, they are then collected by the supplier and further recycled.
