Please describe the proposed development including any change of use:

We propose to demolish an existing shed, which is at the end of its useful life, and request permission to build a replacement shed with the same functions in a different location of the plot. The functions of the existing and proposed sheds are housing livestock (sheep and poultry kept as a hobby), and storing animal feed and wood.

The proposed shed would have a smaller volume (approximately 29.3%) relative to the existing shed, resulting in greater openness (volume of existing and proposed sheds = 112 and 79.2 cubic metres respectively).

If permission is granted, we request that the existing shed be demolished immediately after, rather than before, the proposed shed is complete, in order to ensure continuous housing for our livestock.

In terms of buildings, our 0.98 acre plot comprises a house, a garage, a small outbuilding and a shed. The outside space includes vegetable plots, fruit trees, ornamental trees, and grassed areas. The poultry (15 individuals) and rare-breed sheep (eight individuals) that we keep as a hobby and for personal consumption of eggs and meat, are free to roam throughout most of the plot. The existing shed is used to house livestock and to store animal feed and wood, and the proposed replacement shed would have identical functions. The site of the proposed shed is currently a grassed area which comprises part of the grazing/foraging area for our livestock, which are kept as a hobby.
