Sycamore (T1) - to crown lift to give 4m ground clearance and crown thin x 10% to allow more light through canopy
Ash (T2) - to fell due to potential dieback in canopy and large cavities around stem
Ash (T3) - to crown lift over garage to give 1m clearance of roof
