Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Reduce size of low hanging branches over pavement for health and safety reasons. To cut back any further over hanging branches near 1 Haworth Close and request to "top out" upper with following works :

- Single out large, overhanging branches having a narrow angle attachment and crossing branches. Undercut the branch a few inches away from the trunk to prevent bark tearing so that the tree height is reduced and the tree will put its energy into a shoot rather than trying to produce a load. This will remove limbs that extend beyond the natural crown of the tree.

Cut Branch number 1. (Photo attachment number 1) - 1. Closely spaced , hanging branch

Cut Branch number 2. - low hanging, crossing branch, closely spaced branch (Photo attachment number 1)

Cut Branch number 3 - low hanging . (Photo attachment number 1.)

- Single out large, malformed branches and those growing from the same spot on the trunk. Undercut the branch a few inches to the trunk to prevent bark tearing, seal it off to reduce decay and prevent the entry of disease pathogens.

- Cut Branch number 4 (Photo attachment number 2 and Photo attachment number 1) - large, growing from the same spot on the trunk.

Photo attachment number 3 examples :

- Prune - shortening side branches all over the tree, remove diseased and damaged, dead, crossing limbs and broken branches, to make it smaller and reduces the tree vulnerability to wind damage .

- Remove branches which cross or rub another and give water a chance to collect in the fork.

- Remove branches growing to the centre of the tree, cross limb branches and with weak, narrow crouch branches.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
