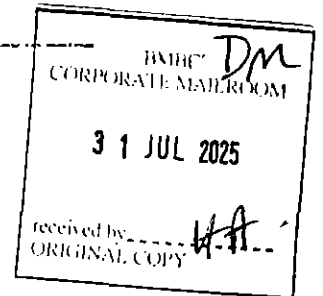

7.8 Identification of trees and description of works

Stones Wood is on the spoil heap of the Victoria Stone Quarry that ceased working circa 1930. This section, through general ageing and management, is regenerating into an Oak woodland as the first growth Birch are gradually being replaced

Three trees, shown on the attached plan as A,B, and C are in need of attention

- (A) A mature multi stemmed Birch at the side of a very popular public footpath. While ostensibly healthy at the moment, the prospect of failure in high winds is disturbing and I wish to fell all stems and retrieve the timber. Photo attached.
- (B) A second mature Birch, again at the side of the public footpath. I wish to harvest the timber. However, I am aware that branches do fall from this tree on occasions.
- (C) An Oak. This tree is damaged and is split. At present it is difficult to approach as the undergrowth is dense. Looked at from a distance, the tree should be felled. Again the timber is to be retrieved. I would appreciate leave to fell, unless the arborist suggests otherwise.
