The planning officer stated that given the unique location of the dwelling, there would be a possible chance of approval but on balance there would be a greater chance of refusal. The planning officer also stated that he would not be confident that an approval would be granted but that he couldn't definitively rule it out altogether. He went on to say that a brick structure would have the best chance of approval.
