Parking is to the front of the property. The tree to the North West boundary is to be retained and the immediate area grassed up to gravel car parking area formed with heel kerbs from access point and adjacent the tree, see plan, to accommodate minimum 3No cars. Application to include for dropped kerbs to access land over the 3000mm wide access point.

Concrete posts with timber infill panels to all boundaries. Generally set at 1100mm from ground level with the exception of the east (rear boundary and in part the North boundary where the fence has been increased in height to 1800mm.

Concrete post and timber infill panels to be replaced to south and west boundary to 1100mm high with 1800 timber panels. East boundary to be replaced with concrete posts and timber panels to 1800mm high. Northern boundary is to remain as post and panel fence and does not require replacement. All timbers to be stained light oak. Boundary to Rectory Road will have 3000mm wide double timber gate built off 250mm² posts all to a height of 1100mm.
